- b) Modify the crosswalk striping on Tamarron to match the crosswalk striping on Highlands Avenue;
- c) Install "Keep Clear" pavement legends on N/B Highlands in front of school driveway;
- d) Install a yield line and yield sign on Hidden Hills Road east of Sandling Court;
- e) Direct staff to review all existing signing, striping and other traffic controls to insure that they are in good condition prior to the start of school;
- f) Direct Staff to provide copies of the Suggested Route to School maps to the six elementary schools for their use as they deem appropriate;
- g) Approve the continuation of the bus shelter advertising program to inform the public about the start of school; and
- h) Direct Police Services to continue enforcement efforts in and around the schools.
