Recommendation

Staff recommends that the City Council:

- 1. Approve Amendment No. 3 to the Professional Services Agreement with Carlson Strategic Land Solutions, Inc. to prepare an environmental analysis for the proposed development of 22 residential townhomes located at 30667 Crown Valley Parkway for an amount not to exceed \$122,000;
- 2. Authorize the City Manager to execute Amendment No. 3 to the Professional Services Agreement and future amendments to the agreement, between the City and Carlson Strategic Land Solutions, Inc.; and,
- 3. Approve a Fiscal Year 2020/21 budget appropriation for a pass-through amount of \$80,000. The costs associated with these services will be paid by the property owner, Laguna Niguel Properties, Inc.
