[Use Permit Amendment UP 00-20A01 \(31371 Niguel Road - T-Mobile @ Clubhouse Plaza\)](#) - A request to modify an existing T-Mobile wireless telecommunication facility at 31371 Niguel Road (Fratello's Restaurant), a restaurant pad building within Clubhouse Plaza. The proposal consists of the replacement of three panel antennas with six new panel antennas affixed to an existing radio frequency transparent roof parapet. The project site is generally located southwest of the Niguel Road and Club House Drive intersection within the "Neighborhood Commercial" (CN) Zoning District.
