Please submit the completed form to the Recording Secretary prior to being heard by the Commission. Each individual will be allowed three (3) minutes, unless extended by the Chair. For each separate agenda item, the Chairman may limit the total time for public testimony. No action will be taken on any items not on the agenda, unless the Planning Commission makes a determination that an emergency exists or that there is a need for immediate action and the need to take action came to the attention of the City subsequent to the agenda being posted.

If you challenge the proposed action of the Planning Commission in court, you may be limited to raising only those issues you or someone else raised at the public hearing, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing.

By Planning Commission policy, no new agenda items will be commenced after 11:00 p.m. If items remain after that time, they will be automatically continued to the next regularly scheduled meeting of the Planning Commission. Any documents that are provided to the Planning Commission regarding items on this agenda less than 72 hours prior to this meeting will be available for public inspection at the public review table that is located in the reception area on the first floor of City Hall at 30111 Crown Valley Parkway, Laguna Niguel, California 92677, until 5:00 p.m. on the date of the Planning Commission meeting. After 5:00 p.m., the documents will be available at the counter that is located inside the City Council Chambers at 30111 Crown Valley Parkway, Laguna Niguel, California 92677.

NOTICED PUBLIC HEARING ITEMS

1. [Environmental Impact Report EIR 22-02, Site Development Permit SDP 16-04, Minor Adjustment MA 22-11, and Tentative Tract Map TTM 17721 \(The Cove at El Niguel Project\) - CONTINUANCE](#) - A request to redevelop the 4.2-acre property with a proposed 22-unit townhome-style residential development. The site previously contained 41 homes demolished following the Via Estoril Landslide in March 1998. The site is within the Residential Multi-Family (RM) Zoning District and is generally located between Via Valle and Club House Drive, at Playa Blanca, on the north side of Crown Valley Parkway.

On August 23, 2022, the Planning Commission held a duly noticed public hearing on the subject project and continued the item to the September 13, 2022 Planning Commission meeting.

Recommended Action: That the Planning Commission take the following actions:

- A. Adopt Resolution No. 22-13, certifying Environmental Impact Report EIR 22-02 (SCH No. 2021110122), and adopting CEQA Findings of Fact, and the associated Mitigation Monitoring and Reporting Program;
- B. Adopt Resolution No. 22-14, approving Tentative Tract Map TTM 17721, subject to conditions of approval; and
- C. Adopt Resolution No. 22-15, approving Site Development Permit SDP 16-04, and Minor Adjustment MA 22-11, subject to conditions of approval.

1. **Cancellation of the November 22, 2022 and December 27, 2022 Planning Commission Meetings** - When the regularly scheduled second Planning Commission meeting in the month of November occurs the week of the Thanksgiving holiday, this meeting has traditionally been canceled.
