#### **PRIMARY FUNCTION:**

Under supervision, this position will observe and receive instruction as to how, and have the opportunity to perform a variety of duties in support of the Planning Division as follows:

- Provide verbal and/or written information in response to inquiries and requests from the public.
- Review building plans and ministerial permit applications to ensure compliance with zoning regulations related to land use compatibility and site design principles.
- Serve as project manager for minor land use entitlement applications, including field work, code and policy analysis, and preparation of staff reports.
- Assist Planning Division staff with various research projects in support of major land use entitlement application review and long range planning activities.
- Perform related duties as assigned.

- Junior or higher student from an accredited college/university majoring in Urban Planning or a closely related field.
