CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT FISCAL YEAR 2021-2022
AND PUBLIC MEETING**

NOTICE IS HEREBY GIVEN that the City of Laguna Niguel's CDBG Consolidated Annual Performance and Evaluation Report (CAPER) for FY 2021-2022 is available for public review and comment.

INVITATION TO BE HEARD: The City of Laguna Niguel received a CDBG allocation of \$366,246 for FY 2021-2022 from the U.S. Department of Housing and Urban Development (HUD). During FY 2021-2022, the City also continued to expend \$551,531 in CDBG-Coronavirus (CDBG-CV) funds, awarded to the City in FY 2020-2021. CDBG funds are intended to assist the City in providing decent housing and a suitable living environment and addressing community service and facility needs for primarily low- and moderate-income persons. During FY 2021-2022 (July 1, 2021, through June 30, 2022), the City awarded CDBG funds to several nonprofit agencies in support of Laguna Niguel youth, elderly, and persons at risk of homelessness. The City also designated CDBG funds for capital improvements and program administration, including fair housing services. Consistent with the CARES Act of 2020, the City utilized CDBG-CV resources to prevent, prepare for, or respond to local impacts of the COVID-19 pandemic. During the FY 2021-2022 reporting period, CDBG-CV funds were allocated to assist youth, the elderly, persons at risk of homelessness, and the homeless impacted by the COVID-19 pandemic. The FY 2021-2022 CAPER details the use of CDBG and CDBG-CV funds during the reporting period of July 1, 2021, through June 30, 2022. The CAPER will be available for public review between September 1, 2022, through September 16, 2022. Written comments regarding the CAPER will be accepted until 3:00 p.m. on September 16, 2022.
