

NOTICE OF ANNUAL BUILDING DIVISION FEE INCREASES

**EFFECTIVE:
July 1, 2019**

In accordance with the City Council Resolution No. 91-129 establishing fees for the Building Division, increases have been made to the construction valuation and non-valuation permit fees based upon changes in the Los Angeles Construction Cost Index published by the Engineering News Record (ENR). These increases will be effective July 1, 2019.

Park-in Lieu Fees	Pursuant to Sections 9-1-522 and 9-1-523 of the Local Park Code, the dollar amount of the Park-In-Lieu Fee is computed by multiplying the number of proposed dwelling units in a development project by the park land acres per dwelling unit as shown in the table below and then by multiplying the resultant acreage amount by the residential land value of the land being developed, per acre.
